Broker/Agent Participation Guidelines

1. A commission will be paid based on the following terms to any properly licensed New Hampshire Real Estate Broker/Agent who submits his or her client's opening bid(s) according to the guidelines as outlined below and whose client is the successful purchaser of the property. Their client must close on the property and must pay the Total Contract Price for the property in U.S. funds to receive the following commission:

Three Percent (3%) commission of the gavel price will be paid.

2. The Broker/Agent commission will not exceed Three Percent (3%) of the price of the property purchased by the Broker/Agent's client.
3. In order to be entitled to any commission, the broker/agent must complete the following steps:
 - A. Register his or her client by filling out the Broker Registration Form in full, including the signature of the client on the form. Submit the Broker Registration Form via mail, fax or email for receipt before the deadline of **August 18, 2014 by 5pm ET** in order to receive the 3% commission.
 - B. Be sure to verify that Braun, Inc. has received your Broker/Agent Registration form by calling 310.798.3123 ext. #212.

- A. He or she has inspected the premises of the subject property.
 - B. Braun represents the Seller in this transaction.
 - C. Commission shall be paid only to Broker/Agent representing client (Buyer/Bidder) as an Agent as acknowledged in this form if another Broker/Agent has not registered him/her with Braun.
 - D. He or she shall hold harmless and indemnify Braun and Seller from any and all representations made by you the Broker/Agent.
